### MAINTENANCE: Mr. Chuck Vessey

Locates continue to be high due to summer projects by homeowners and utility companies. Hydro-cleaning is continuous and whenever a homeowner calls to advise they are cleaning out their line. City planning has advised to Mr. Wallen, they will be taking over the Spaulding Lane development.

#### CITY OF FORT COLLINS: Mr. Brad March

The City of Fort Collins requested, from Mrs. Vessey, a list of all properties served in the District, as well as how many taps each and commercial or residential. District management asked Mr. March to investigate this and if they were intending to take over the District. Mr. March has scheduled an appointment with the City attorney and will report back to the Board next month, but preliminary contacts that he has made do not suggest a desire of the City to take over District operations.
